

# Variation of a Mortgage over Quota Shares

This application must be used to vary a mortgage on the Quota Register. When registered, this memorandum varies the mortgage from the quota shares to the extent specified.

#### Privacy Act 2020 — Collection of Personal Information

Your personal information is being collected to enable the variation of a mortgage to be processed.

The agency collecting and holding this information is Commercial Fisheries Services Limited (FishServe), PO Box 297, Wellington, 6140.
